Dear Parties to the Déljñę 2021 Public Listening Session – This email is to provide notice the SRRB received a request from Colville Lake to have additional time to provide their plan. The request is below. The SRRB is inviting parties who wish to provide submissions on this request to do by **5 pm Friday, November 26, 2021**. Any objection to the request should include submissions why the party considers it would prejudice them if the request is granted.

If the request is granted, the timeline for issuance of Round 3 Information Requests will be delayed until December 9. This is to provide one week for parties to prepare any questions, including any on CCP submissions. Due to the logistics involved in organizing the Déljñę 2021 PLS, the submission **deadline for responses to Round 3 IRs will remain January 14, 2022**.

As the PLS approaches, we acknowledge the work being done by parties to prepare. The SRRB appreciates your fulsome engagement and encourages all parties to continue to represent their interests. The SRRB continues to work toward the overall question, “What is the most effective way to conserve caribou?” The SRRB will continue to work with community conservation planning in the Sahtú region, including through the 2020-2024 PLS Series.
