Charlie Neyelle – Addressing meeting

Thanks for allowing to address the meeting. Happy we have a board that talks the way we do. Wildlife on the land – caribou, caribou has own laws they follow it, dene people harvest are of most, if the caribou follow the natural laws and we do then no problem with caribou in the future. We are no managers of caribou, it is important of all stake holders aware natural laws of caribou, land so important for caribou, food etc... Law, broader sense than in English language, hard to translate. Cows reproduce young, bulls important too. Dene people own way of hunting, follow traditional ways for hunting. Pattern in fradition, huge problem translating dene to english

## 6. Sahtu Land and Water Board Presentation – Joan Gordey

Potential MGM application has not arrived yet, Sept. 29 community meeting Tulita and Sept. 30 in Norman Wells towards the end of Oct/Nov. Jan 2011 proposed to start if successful possible second drilling the next year.

MACA – responsible for Land Use Permit try to send out package in whole so more complete for reviewers. SLWB environment screening and evaluate it and MACA will adopt screening, water license renewal from MGM and Husky, Little Smith staging area. Many requests for renewals and extensions from Husky and MGM. Remediation and rec. On 6 husky sites – filling and contouring sumps, MWH did remediation. – Sumps are now well contoured and protected from erosion ves coming in well – good ground cover.

Selwyn – Reassignment to Selwyn Chihang Mining Ltd.

Howards pass some up to 25 years. MACA and SLWB work together for Municipal applications. Changes at SLWB, we have a new executive director and a new land tech.

Q - How do inspections work in overlapping jurisdictions?

Rumours at Selwyn water uses hydro dam, have you heard any at SLWB Heard Oct. 12 – discussion on with MLD.

Q – Selwyn is the largest lead deposit in North America, spin off effects how to sustain 9 large projects, where do they get the power and electricity for it?

Still rumour, what planning ur where hydro facility.

Q – If proposed in park, then what?

Chris – Territorial government maybe trying to veto the park? Discussed later in agenda.

Keith – Winter road bridges in applications if still valid for years is there still work happening this winter?

Joan - Black Water bridge is complete, closing some of water licences because bridges are stable and no erosion. Three that will not be closed because still is use. Geo tech work in Tulita for highway. In negotiation with the K'usho gotine distirct, no land use permit or water licences.

Last week in Whitehorse largest public mining announcement Selwyn – China large party a lot behind the scene who were players? Sahtu? NWT?

Provisions for MACCA to negotiate with SLWB on how to handle applications. ENR responsible on crown land.

INAC will do water licence inspection. MGM drilling fluids, spread out, land farm, not sure if used before in NWT, under SLWB jurisdiction because under disposal of waste.

Chris – requested last year's auditor provide previous years of financial records for comparison. End of March 200,000 dollars less than previous years. Take time for members to review financials, meetings that have not been reimbursed for, Jody's severance pay, two Executive directors for 2.5 months, approx total \$140 K, why larger amount than previous years

Gord – something done until payment

Chris – Invoices for Caribou engagement meetings sent to Susan Fleck. She offered this money in January for conservation education on the 2<sup>nd</sup> week of March for 25k but have to spend the money before March 31. Told her that there was no way we could spend this money before March 31. We sent in a claim for cost for the meeting that we thought were conservation education but still did not receive the money.

Gordon – Suggestion for solution for matter, writing a letter to Susan Flect.

Chris – Talk of renewal of harvest study in the spring but only on large mammals only ACWM.

Gordon – Suggestion to have investment people at next meeting to see why we are losing money.

Chris – Only to use interest for the research funds only for incoming research.

7.a Bluenose Ease Caribou Herd Photo census results Presentation – Heather Syine-crawford

2006 – 66 thousand caribou, last year non due to bad weather; didn't bunch for pictures. June 1 – 10, 2010 calving ground survey

Gordon - Where is the company based that counts the caribou from the pictures?

Heather – Not sure – Ontario is where one of the scientists is from. Been counting from the pictures his entire career.

Results – end of March, RRC boards will receive estimates first before press, no official numbers but at least 80,000 caribou since 2006. Positive sign for bluenose ease.

Leonard – is Kugluktuk participating with surveys?

Chris – Walter has relationship up at Kugluktuk gets some data, caribou doesn't seem as much as priority in Kugluktuk as here. Community members flew up to Kugluktuk to observe caribou from Norman Wells, Tulita and Deline. A list requested from Walter of attendance names.

Gordon – If to compare survey to 2006 ex: in same years conditions not as accurate? Were surveys similar?

Heather – No, followed same protocol Boyan also was there.

Joan - Were same transect lines used as in previous years.

Heather – Yes, not much space to miss any animals.

Walter - Snow pictures was that in June

Heather – Yes, helps keeps bugs away

Leonard – how many hers present

Heather – 36

Leonard – mixing of two east and west:

Heather – collars show so far hasn't showed to much mixing.

Leonard – Can pictures tell if mixture of east and west

Heather – No, collars

Walter – no way of telling – NDA needed
