### Bluenose West survey permit application

- On August 27, 2020 the Board received a Wildlife Research Permit application for the following project: Collaring, Monitoring and Population Estimates of Tuktoyaktuk Peninsula, Cape Bathurst, and Bluenose-West Barren-Ground Caribou
- ENR plans on collaring 60 animals from the Bluenose West herd.
- Collaring will be done in the Inuvialuit Settlement Region.
- The Board reviewed a response letter drafted by staff to the Minister outlining the feedback we heard from Sahtú Communities over the years.
- Sam Hache will revise the response draft letter to include the SRRB's position that Sahtú communities are against the collaring of caribou but that support other region's right to choose how best to conserve their caribou.
- The response letter will be signed by the Chair instead of staff.
